Set up: Saturday, June 9th, from 7am – 9:45am. No Exceptions.

Vehicles will be allowed on the street for unloading until 9:30 am. ***Absolutely NO vehicles will be allowed after that time.*** It is a safety hazard to both vendors and customers.

You are expected to show up on time. ***Latecomers will not be accommodated, as it inconveniences vendors who were on time, as well as DRI coordinators,*** who will already be extremely busy. Please be cooperative and respectful.

Tear down: Saturday, June 9th, 2018; AFTER 3:00 p.m. No Exceptions.

Absolutely NO tables or materials may be removed before 3:00pm. Exhibitors may park near their booth for loading only after 3:00pm. Vehicle must be moved immediately after loading or vehicles will be towed at owner's expense.

Vehicles may be parked in designated parking areas during show hours and setup times.
